## **EVERGLADES COMMUNITY CHURCH**

The "Church on the Circle" was built in 1940 after the Collier Corporation gave the land with the stipulation that the building be completed during that year and that it be a non-denomination Christian establishment. Previous congregations of Presbyterians had met in Everglades City in various locations, including the old Community Center (the "movie theater") on the east corner of Broadway and Allen Avenue (then called Royal Palm Avenue).

The Church is now researching its history further and would like to restore the main building to its original state. However, they need first-hand reports and photos of how the it looked in the old days. Any pictures or documents will be copied and returned to you.

The bricks from the previous campaign will be shippped on January 26 and should be installed in time for Seafood Festival.


