## **Colliers Celebrate 100 Years**

We were honored to have grandsons of Barron Collier here in Everglades City for the events celebrating our unique hsitory.

On April 29th the Museum focused on the 95th anniversary of the Tamiami Trail during which Terry Collier read the speech given in 1928 during the official opening in ECity

For the official County celebration on May 8, the date in 1923 when legislation was signed creating Collier County, Barron Collier III ("Barry") spoke about his famous predecessor at a ceremony in ECity which was the biggest town in the area 100 years ago and designated the County seat.

The original Barron Collier was interviewed by the Fort Myers News-Press on May 7, 1923, and is quoted:

"I intend to build the Tamiami Trail just as fast as it is possible to do it ... I realise that I have a great task ahead of me, but I have set my heart to that task, and I am sure that with my associates, I will be able to make it possible for many thousands to live where a few hundred have been living. If I succeed in this it will be blessing to all of Florida ..."

### Thanks to Tommie

Although she is called the "Queen of Marco" she should also be recognised as the "Midwife of Collier County".

When the legislature was debating the establishment of Collier County in 1923, there were objections from Lee County which would be diminished when so many acres were carved out. It is thanks to Tommie Barfield, who travelled to Tallahassee to represent our area, that the legislation passed.



There will be a talk about her life on Thursday, July 20, which would also be her 135th birthday, at 2:00pm, in the Museum of the Everglades and there is a special exhibit at the Marco Island Historical Museum until August 5. For info, see the County website www.colliermuseums.com.

## **Save Taxes and Help ESHP**

## ROBERT (BOB) FLICK, 1936-2023

## A Personal Remembrance by Patty Huff, ESHP President

Bob Flick owned the Bank of Everglades Building from 1996 until he donated it to ESHP in April 2021.

Bob Flick was a remarkable man whom I met over 20 years ago when we both played tennis with a neighborhood group at McLeod Park in Everglades City. Anyone at any level in the community could come out and play; no rules, we just enjoyed playing tennis.

Bob with his daughter Patty had purchased the abandoned Bank of Everglades Building. Being interested in our history, I was pleased to watch as they transformed the historic building into a stunning Bed & Breakfast in 1998. For nearly 20 years the building was used as a B&B until 2017 when it was left unoccupied.

Preserving our history and culture was always important to Bob who, after he was unable to sell the building, was determined to restore it. I would stop by the Bank building and observe him knocking down interior walls and asking for early photos.

Eventually, when he realized it was too difficult to do this on his own, Bob donated the Bank Building to the Everglades Society for Historic Preservation which has recently received federal funding to rehabilitate the building as the Everglades Area Visitor Center and Trail Town Headquarters with a gift shop, art gallery, historical library, and conference room.

Bob's only request when he donated the building was that the film "Wind Across the Everglades" would be shown. The original bank vault will be named the "Bob Flick Theater" and visitors will be able to see the movie in which Bob played an extra.

The Everglades Society for Historic Preservation will be eternally grateful to Bob for his generosity and dedication to keeping our history alive.

Thank you, Bob.

I will always remember our talks and your hard work.

**Editor's Note:** Bob Flick moved to Naples from Ohio in 1957, the year that "Wind" was being filmed in Everglades City.
